The integrity of the nominated official may also be certified. The eligibility criteria for the post of Constable are given at Annexure "B".


5. All these posts have all India transfer liability at Bureau Hqrs. and its six outlying units located at Bhopal, Kolkata, Hyderabad, Chandigarh, Jaipur and Ghaziabad.
