- apply the intelligence analysis research process when searching the Internet;
- apply various search techniques to effectively search the web;
- search indexed and non-indexed web sites;
- describe the importance of being anonymous while gathering intelligence on an identified occurrence;
- describe Web 2.0 and its intricacies;
- protect their online identities using obfuscating tools; and
- Archive a website for offline viewing.

(d) **Training Charges:**


All the training charges will be borne by Ministry of Home Affairs, GOI.
